GUEST SPEAKER

Stephanie Sampson, LAWA Director of LAMP Communications gave an overview of the progress on the LAX \$5.5 billion Landside Access Modernization Program (LAMP) such projects include the Automated People mover, the Maintenance & Storage Facility, the Consolidated Rent-A-Car facility all slated to be complete 2023, and an Economy Parking structure.

The new LAX Economy Parking Structure is the first element of the LAMP program to be complete. This structure will open to the public on Tuesday, October 19, 2021. The structure features approximately 4,300 stalls and includes state-of-the-art Smart Parking, electric vehicle charging stalls, a shuttle to the Central Terminal and more.

LAX Passenger Traffic

Passenger numbers increased last month compared to 2019 by 63.2%. Average passengers in September were 70,240. We also see a 37% increase between Jan. 1 to August 31 compared to 2020 with a total of 28.7M passengers.
